Purpose:

To establish a policy on approved smoking areas.

Policy:

Wintergreen Fire and Rescue is a tobacco free workplace. Tobacco use is not allowed on any Wintergreen Fire and Rescue staffed property.

All full time Fire and Rescue employees shall follow the Wintergreen Fire & Rescue Department Conditions of Employment agreement regarding tobacco usage.

Reference Drug Use Policy, ADM 02-006 for more information regarding a tobacco free workforce at Wintergreen Fire and Rescue.

For the purpose of this policy, vaping is considered tobacco.
